Section 4: FIRST AID MEASURES

Keep out of the reach of children. Keep container tightly closed and dry. Do not store at temperatures above 49 °C / 120 °F.

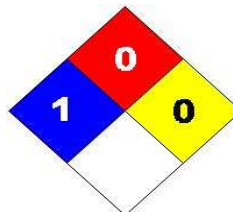
